### **RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT/PHOTO RELEASE**

I/We the undersigned hereby certify that I (we) am (are) the parent(s) or legal guardian(s) of the athlete.. In consideration of participating in Atlanta A.C.E. (DBA A5 Volleyball) activities such as tryouts, training, camps, tournaments, etc., I (we) represent that I(we) understand the nature of these Activities and that I (my child) am qualified, in good health, and in proper physical condition to participate in such Activity. I (We) acknowledge that if I (we) believe event conditions are unsafe, I will immediately discontinue participation in the Activity.

I (we) fully understand that these activities involve risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by the athlete's own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "Releasees" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I (we) fully accept and assume all such risks and all responsibility for losses, costs, and damages incurred as a result of my (the athlete's) participation in the Activity. In the event a refund is required for a class, camp or training session, the refund amount will be in the amount of the class, camp or training session less the applicable processing fees.

I (We) hereby release, discharge, and covenant not to sue Atlanta A.C.E. (DBA A5 Volleyball), Southern Volleyball Center, LLC, Alpharetta Family Skate Center, Peachtree City Volleyball Center, their respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, other owners and lessors of premises on which the Activity takes place, (each considered one of the "Releasees" herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations; and I (we) further agree that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, I (we), or anyone on our behalf, makes a claim against any of the Releasees, I (we) will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage, or cost which any may incur as the result of such claim.

#### Specific Covid-19 Issues

### COVID-19 Health Protocols:

1. Signage will be posted at entrances and exits indicating Atlanta A.C.E. (DBA A5 Volleyball) is invested in following the correct health protocols. These signs will clearly state one cannot gain entry if you have COVID-19, are experiencing symptoms of COVID-19, or if you or any of your friends or family members have been exposed to COVID-19.
2. All coaches, staff members, and players will have their temperatures taken prior to the beginning of practice.
3. Initially, spectators will not be allowed in the gym.
4. All players must sanitize their hands upon entry.
5. After cleaning their hands, players must place their bag and personal items in a designated area separate from the other players bag and items.
6. Coaches and staff members will sanitize their hands prior to and multiple times during practice sessions.
7. Players will sanitize their hands multiple times during their training session. Hand cleaning stations will be in place on all occupied courts.
8. Coaches will closely monitor all players at all times. Players must stay on their assigned courts.
9. At the end of the training session coaches and staff members will clean their assigned balls, ball carts and any other training equipment utilized.
10. Bathroom facilities will be frequently sanitized and cleaned.
11. There will be no use of the water fountain during these training sessions.
12. Initially, players will enter in the front of the building, and exit from the back of the building.

It is absolutely required of everyone to either wash or sanitize their hands after using the restroom, sneezing, coughing, and before participating in any activity.
